Non-accessible Content

The following content is currently **not accessible**, in violation of the criteria set forth by Law 4/2004 and the applicable technical standards:

- **C.9.1.1.1** – Some non-text content does not have equivalent text alternatives.
- **C.9.1.3.1** – On certain pages, structure and information are not programmatically identifiable.
- **C.9.1.4.3** – The visual representation of text does not always meet minimum contrast requirements.
